


Location

The city of Lynchburg is located near the geographic center of Virginia. Located on the James River, the city is bordered on the west by the Blue Ridge Mountains. The city is a major highway and transportation hub that has contributed to its status as a broadly diversified manufacturing center.

Located just 180 miles southwest of Washington, D.C., Lynchburg is located within a one-day drive to all major metropolitan areas on the east coast. With daily air service to Charlotte, NC at the Lynchburg Regional Airport and daily Amtrak service to Washington, D.C. and points north, Lynchburg is an idea location for easy access to travel, business and entertainment opportunities. Located 115 miles west of Richmond, the state capital; 52 miles east of Roanoke; and 200 miles west of the Port of Hampton Roads.


Lynchburg is the central city of the Lynchburg Metropolitan Statistical Area (MSA).

Downtown Lynchburg on the banks of the James River with views of the Blue Ridge Mountains.





Government and Taxes

Government

Lynchburg has a Council-Manager form of government with seven elected council members. Four ward seats and three at-large seats are elected bi-annually.

The city has recently updated its Comprehensive Plan and Zoning and Subdivision Ordinances.

Taxes

Localities in Virginia collect a 1% sales tax. They do not tax other items taxed at the State level.

Counties and cities in Virginia are separate taxing entities. Therefore, a company pays taxes to either a county or to a city.

If a company is located in a town, it pays town and county taxes except for utility taxes which are paid only to the town and the license tax which is paid only to the town unless town law permits the additional collection of a county tax.

Manufacturers pay real estate, machinery and tools, truck and automobile, utility, and sales taxes.

Nonmanufacturers pay real estate, tangible personal property, truck and automobile, utility, and sales taxes. They also may pay either a merchants' capital or a license tax.

Community Facilities

Lynchburg is home to Centra Health, a non-profit family of hospitals and physicians providing award-winning care. Facilities include Lynchburg General Hospital, Virginia Baptist Hospital, the Alan B. Pearson Regional Cancer Center and the Stroobants Heart Center.

Virginia Baptist Hospital with 317 beds provides obstetric, medical-pediatric, neonatal, cancer care, mental health and chemical dependency treatment, home health, and physical rehabilitation for the area. Lynchburg General Hospital, with 270 beds offers emergency and trauma care, cardiology, neurology, critical care, orthopedics, and neurosurgery services. Centra is recognized as one of the Top 50 Cardiovascular Hospitals by Thomson Reuters, and Forbes Magazine placed Centra in the Top 5% of Safest Hospitals in the country.

Centra includes 6,000 employees, a medical staff of 490, with physician practices serving an area from Bedford to Farmville and from Nelson County to Danville. In addition, Centra's services include residential and outpatient mental health facilities, home health and hospice programs, mammography centers, a sleep disorders center and a center for wound care and hyperbaric medicine. The Lynchburg Health Department provides a variety of public services and clinics.

Lynchburg has many opportunities for religious expression with over 130 places of worship representing 35 faiths, including Catholic, Jewish, Greek Orthodox, and most Protestant denominations.

The Lynchburg Public Library is centrally located in a newly renovated facility at the Plaza Shopping Center. Jones Memorial Library, a privately endowed historic and genealogical research collection, is also located in the public library building. The downtown branch serves as a reading, research, and resource center for the downtown workforce.

In Lynchburg, we have a good balance of locally-owned boutique shops and major designer labels, including one of the nation's

only J. Crew warehouse stores! Between the well-developed commercial strip on Wards Road, Boonsboro Shopping Centre,

River Ridge Mall, and local boutiques speckling the City, you can access everything you need within a quick 15-minute drive.

River Ridge Mall offers a large movie theatre, and popular brand-name stores.

Our Parks and Recreation Department has worked diligently to make Lynchburg a jewel of community livability, dedicating over 800 acres to 16 parks, 24 playgrounds, 34 tennis courts, 26 baseball diamonds, eight community centers and two nature preserves, all spread conveniently throughout the city. Two country clubs offer golf, tennis, swimming and banquet facilities.

Theaters, Galleries, Museums...oh my! Lynchburg is the arts, cultural and entertainment hub of the Central Virginia region, with year-round offerings of visual and performing arts, a host of galleries featuring local and global artists, and theatres hosting local productions and nationally-recognized touring troupes. Come see what a home-grown, organic arts scene looks like, or enjoy arts and cultural offerings typically found only in large cities: like our symphony orchestra, Opera Company, ballet and modern dance troupes, and a variety of performing arts groups and theaters.

Lynchburg is also alive with history. You can see it in our historic neighborhoods, our award-winning museum system, our national heritage sites, and the many surrounding battlefields from the Revolutionary and Civil War eras. From Thomas Jefferson's estate at Poplar Forest to the surrender grounds at Appomattox, our entire region is rich in the history and cultural heritage that has defined our nation.

There is no shortage of things to do and places to see in Lynchburg and Central Virginia, for couples, for families, for young and old alike. Enjoy Friday evening concerts in a riverfront park, an array of historic sites, a nationally-renowned children's museum, frequent summertime block parties and weekly celebrations of art and music.

Professional baseball is available in the city. The Lynchburg Hillcats, Advance-A affiliates of the Atlanta Braves, participates in the Carolina League.

The city of Lynchburg operates 12 parks, 24 playgrounds, eight community centers, one swimming pool, 40 tennis courts, and 26 baseball diamonds. A full range of athletic, dance, and arts and crafts classes are sponsored by the city. Two country clubs offer golf, tennis, swimming and banquet facilities. Other golf courses and country clubs are located in the surrounding counties. Annual amateur golf and tennis tournaments enjoy substantial community and business support.

The Blackwater Creek natural area and the nearby Blue Ridge Mountains offer numerous hiking and camping opportunities along the Appalachian Trail. Smith Mountain Lake, one of the country's largest man-made lakes (20,000 acres), provides excellent fishing, swimming and boating. Local colleges participate in the full spectrum of individual and team sports including NCAA football, baseball, basketball and soccer.

Historic neighborhoods and attractions are prominent throughout the community. Several historic districts highlight distinctive architecture and are focal points for tours and community celebrations. The Lynchburg Museum System operates Point of Honor, a 19th century restored mansion with period furniture, and the Old Court House, containing a museum of the City's history. Thomas Jefferson's 18th century octagonal summer retreat, Poplar Forest, is in nearby Bedford County and is being restored as a major historic attraction.
